Student Resource Scheme & Subject Levies 2025 – Important Information

Dear Parent/Carer

This letter contains important information about the 2025 Student Resource Scheme (SRS) and Moranbah State High School 2025 Subject levies.

Student Resource Scheme:

In previous years, fees have been charged to families per student as part of the student resource scheme. In 2025 Moranbah State High School acknowledges the cost-of-living strain on families and is proud to advise in 2025 no out of pocket costs will be charged to our families.

The attached document shows for each year level the resources included in the SRS which will be provided to each student as part of the Textbook and Resource allowance.

A parent can opt out of the scheme by completing a Participation Agreement Form indicating that they do not wish to participate and return to the school office by 7th February 2024. If a parent has opted out of the scheme the parent is required to provide the educational resources listed in the SRS for their child.

Subject Levies are separate to the SRS and are for subjects not covered in the SRS or that utilize a higher volume of consumables e.g. Cooking ingredients, art supplies.

The attached document lists all subjects that have a subject levy.

Subject Levies

Year 7 & 8 – all students choose either LOTE (Japanese / AUSLAN) or Coding for one semester and all students participate in HPE for one semester.

Subject levies will be invoiced each term for your child's current elective choices as per their timetable.

Year 9 – students choose electives for semester 1 and 2. Subject levies will be invoiced each **semeste**r for your child's current elective choices as per their timetable.

Year 10, 11 & 12 - subject levies will be invoiced in term 1 for your child's chosen electives.
